THE NEW WORDING AND REQUIREMENT WAS, IN FACT, ON THE FORM THAT WE HAD ALREADY FILED... HENCE THE NEED FOR AN AMENDMENT. THE AMENDMENT REVISES THE NUMERICAL DATA AND COMMENTS AS REGARDS THE 100-DAY COUNTDOWN CLOCK.
